Draft Minutes of the 2021 Annual General Meeting

Minutes of the Annual General Meeting

of the

Congregation of Beach United Church

March 6, 2022

Hybrid meeting held on Zoom (37 attendees*) and in the worship space at Beach United Church, 140 Wineva Avenue (11 attendees**).

1. Welcome

The meeting was called to order at 11:30 by Nanci Harris, Chair of the Board of Beach United Church. Nanci welcomed participants on behalf of the Board and thanked them for their attendance, whether in person or virtual.

2. Opening Prayer

The Reverend Greg Daly opened the meeting with a prayer.

3. Team Introductions

Nanci introduced members of the Board: Brian Gautier, David Kiel and Barry Watson and Lynne Fulcher, M&P Chair & Greg Daly as non-voting members.

Nanci reviewed the meeting agenda.

4. Motion to approve Voting Privileges

Leigh Bower made the following motion:

"For the purpose of this meeting, everyone present, both members and adherents, have voting privileges."

Seconded by: Pat Davies The motion carried.

5. Motion to approve 2021 Meeting Minutes

Shirley Underwood made the following motion:

"We accept the Minutes of the February 28, 2021, Congregational Meeting."

Seconded by: Richard Underwood

The motion carried.

6. Year in Review

Barry Watson provided a summary of the 2021 year. He noted that BUC has been in a difficult position for the last couple of years, but we are now in a position to be optimistic and move

forward. We have been able to continue many activities, and there has been growth in unexpected ways. For example, we have been surprised and delighted with our ability to generate online fundraising activities. Our finances are fairly strong. We have begun the year with Greg joining us and bringing his energy for moving forward. While we are mindful of the difficulties we face, we nonetheless have reasons to be optimistic.

7. Our Goals

Barry Watson noted that the Board is satisfied that there is no need to revise our current Strategic Plan and Goals (articulated in the 2017 Strategic Plan). Activities may change in the coming year, but our goals and mission remain the same.

8. Activities of the Year

Barry Watson noted that during the past year, the Beach congregation has continued to be creative and busy. We have come up with ways of moving forward with worship services, both online and in person. He offered thanks to everyone for their patience while bringing services online. Barry also highlighted the contributions of the following individuals and programs:

- Continuation of Beach's community food programs which provided inside lunches when
 possible and outside when not. Thanks to Jim McKibbin and his work, now being taken
 over by Hastings Withers with the support of Jim Winn. Also the Community Cupboard, a
 new initiative in food outreach, with thanks to those who initiated and those who continue
 to contribute.
- Music program Steven has provided music programming and engaged the choir as much as possible. Jazz and Reflections has been able to continue.
- Fundraising Online fundraising continued through the leadership; thanks to JoAnne
 LaForty for her leadership role. The online Christmas market was another success and sold
 out this year and the documentary series looking at social justice issues coordinated by
 Mary Anne Lemm. Also, the work of the Environmental Action Group led by Paul Dowling,
 Ron Fitton, Allan Baker and others continued.
- On an ongoing basis, all activities within the church are now considered for their sustainability and impact on the environment. The parking lot has been a way of engaging environmental thinking and our solar panels are manifestations of our environmental sensitivity and our ability to translate belief into concrete action. Most recently, some work is underway to instal an electric vehicle charging station for the parking lot.
- Parking lot there was some decrease in revenue last year, but it has increased over the last few months.
- Solar panels while the co-op is technically at arms-length from the church, we acknowledgment its financial contribution to the church, and in particular the work of Martin McFarland. The solar installation has been one of the best financial investments the church has been involved with.

9. Connecting Activities to Goals

Nanci presented a chart which demonstrated the alignment of our activities (see 8., above) with BUC's strategic goals. She noted that over the past 2+ years of ups and downs, it is reassuring that these 4 pillars continue to sustain us. And they continue to serve us very well during this transitional year (2022).

10. Acknowledgement of Volunteer Leadership

Nanci acknowledged the contributions and BUC's gratitude for the work of ALL volunteers and underlined the desire to continue to celebrate the work of all volunteers, especially during these last few years.

Specific acknowledgment was given to individual volunteers in the following groups:

- Trustees
- Board of Directors
- Ministry and Personnel (M&P)
- Operations Advisory Group (OAG)
- Leadership in Fundraising and Special Projects
- Animators
- Givings, Counters
- Pastoral Care

Nanci acknowledged the key roles which staff at Beach play and the significance of their contributions to the life and wellbeing of the church.

Nanci also clarified the role of the Operations Advisory Group, which provides direct guidance to staffing support and decisions about the building. She concluded with an open invitation for people to express their interest in volunteering in one of the many ways Beach interacts with the community.

11. Challenges and Opportunities

Nanci highlighted two specific challenges and opportunities for 2022:

- Increasing volunteer capacity, and
- Resolving staffing needs as activities evolve over the next six months, as Greg gets comfortable in the work.

Greg continued the presentation by highlighting the following challenges and opportunities for 2022:

• Strengthening worship and pastoral care – creating opportunities to explore making meaning in our lives together, and ways of deepening faith and our connection with each other. He is working to manage the transition in ways that offer this, looking at innovative

and creative ways to worship, and offering spiritual care supports as he gets to know the congregation. Greg invited participants to please reach out to him when it makes sense for them.

- Re-establishing in-person activities Greg noted that as we re-establish in-person
 activities, we are seeking to do this with safety as our paramount goal and we are trying to
 meet the needs of people to engage in ways they are comfortable. That we will continue
 to balance the needs of our community in the context of provincial changes to in person
 activities. He invited feedback as different platforms are experimented with as to what is
 working and what doesn't.
- Engaging in external partnerships for social justice BUC has been here for a long time but there are still people in particular, locally who may not know who we are. BUC is integral to the community and we will continue to ask what we can offer to the Beach community so that people see the congruence between our words and actions. Greg welcomed ideas from the congregation about how we can be present to the needs of this community.

12. Financial Health (See Appendix 1 for details.)

David Kiel reviewed BUC's financial results from 2021, with comparisons to the past 3 years.

Summary Financial Results

David explained that in 2021, BUC's net income Over the past 2 years, these government subsidies ended in October 2021. The 2022 budget will not include these and, coupled with re-opening and opportunities for revenue generation will be closely monitored as a result.

• Summary Balance Sheet

2022 Budget – David reported that the transitional nature of this year has made it very difficult to forecast. As such, this is considered a transitional budget and is very conservative. It was completed at the end of January and may need to be revisited. Things may change based on some of the direction that the Board and Greg undertake.

For example:

- Rental income is already up from January, and parking lot revenues have also increased. There were a number of PAR cancellations at the end of 2021., due to moves, etc. PAR is down as a result. - Additional repairs and maintenance are needed for the church; expenditures in the past few years have been flat.

Motion to accept the Budget as presented

Dave Buchanan made the following motion: "We move to accept this budget as presented." Seconded by: Megumi Nishikawa The motion carried.

13. Additional recognition for BUC Volunteers

Nanci acknowledged the work of Marian Hilton, Pat Plue, Frank Plue in collaboration and under the leadership of outgoing minister Karen Dale and others who have supported the congregation with Pastoral Care during the year. Shirley Underwood will be joining the pastoral care team for 2022.

14. Board of Directors 2022-23

Nanci thanked Barry Watson, Brian Gauthier and David Kiel for their incredible leadership and for their work on the Board over the last few years. Thanks were given also to outgoing chair of M&P, Frank Plue.

For 2022, David Kiel will continue as Treasurer, ex officio. Lynne Fulcher, Chair of M&P, ex officio and Greg Daly, ex officio, will also attend meetings and work with the Board.

Nanci noted that the Nomination Committee of the Board (herself, Barry Watson & Ron Fitton) is working to fill the remaining 3 Board member vacancies. The Nomination team is engaging with those volunteers who have come forward with interest to join the Board. It is not too late for volunteers to come forward. Those who are interested can still email the Board at board@beachuc.com. The Board will continue this process and call a short congregational meeting by the end of March to vote on the slate of nominations for the new Board soon.

Ministry & Personnel Committee Report

The Ministry and Personnel (M&P) Committee provides human resources support to the congregation which includes:

- regularly reviewing the working conditions, responsibilities, and compensation of all Beach United Church staff.
- revising position descriptions of pastoral charge staff as needed;
- conducting annual performance reviews of BUC staff;
- being available for consultation and support for matters involving BUC staff; and
- overseeing the relationship of BUC staff to each other and to people in the congregation.

Presently the M&P committee consists of three members, specifically Lynne Fulcher and Karen Watson (co-chairs) and Henny DeLange.

This year we welcomed Rev. Greg Daly in February, supporting him through his six-month transition period and developing his final job description.

In April we worked with Greg to organize his covenanting service. We want to thank those members of the congregation who were involved in that service.

In June we began the process of reviewing our current organizational structure and what our future needs would be. We offer our thanks to OAG members Ron Fitton, Brian Gauthier, Barry Watson and Jim Winn for their participation in the development of the new staffing model. This was approved by the Board in August. With the support of OAG, the M&P committee led the recruitment and onboarding of our new lay staff: writing job descriptions, advertising, participating in interviews, developing contracts, arranging for police checks, drafting offer letters, and ensuring staff were on the payroll and receiving benefits. Many thanks to Martin McFarland for his payroll support.

We were delighted to welcome Allison Woo, BUC's new Communications Coordinator, and Karen Cornece, BUC's new General Manager. We established and recruited members for the Communications Advisory Committee, which is leading BUC communications with the support of Allison Woo, our Communications Coordinator. We attended regular Board meetings. To live out BUC's commitment to supporting a living wage for all staff, we reviewed and adjusted staff salaries to ensure that all staff were receiving a Living Wage (In Toronto a Living Wage is \$22.08 per hour).

2023 activities will include:

- A search for a children's programming leader
- Staff performance reviews (February)
- Working with the General Manager and OAG to hire and onboard the new Property Manager and Events Coordinator.
- Revision of BUC's Harassment, Violence, Discrimination policy to current standards;
 mandatory staff training and optional volunteer training.

Thanks to all volunteers who participated in the recruitment of our new staff, developing interview questions, sitting on interview panels and checking references: Leigh Bowser, Mary Anne Lemm, Henny DeLange, Jerry Reitsma, Ron Fitton, Brian Gauthier, Kathy Clemens, JoAnne LaForty.

Thanks also to Leigh Bowser, MaryAnne Lemm, JoAnne LaForty and Greg Daly for agreeing to be members of the Communications Advisory Committee. We also want to thank Cate Duff and Ron Fitton for all the extra time and energy they have put in since David left.

Operations Advisory Group Report

- 1. Rental Income for 2022 reached just over \$130,000. Much of these events were booked well in advance, with many added since September.
- 2. Parking revenue has returned to pre-pandemic levels. The addition of EV chargers has not impacted this so far.
- 3. EV chargers are fully functional, following resolution of a couple of early glitches:
 - Charging connections being interrupted
 - Idle charges (remaining plugged in after charging has ended) being applied inappropriately.
 - Site not well known. Signage is in progress and expected by end January
 - Several neighbours have used the chargers, and an on-line network seems to be developing.
 - Councillor Layton posted congratulations from his social media.
 - Video filming by Signature Electric schedule for spring, to be posted on their network.
 - One of two funding supports has been received, the other is expected early in 2023.

4. Staffing

Hiring progress very slow:

- 3 new positions posted late Sept: General Manager, Rentals Coordinator, Property Manager
- The hiring process moved slowly through the fall, with results as:
 - Karen Cornece started as General Manager in November
 - Virginia Gallop started as Events Coordinator in February
 - Property Manager posting released Jan 10, with interviews proceeding early in February.

Huge appreciation to the volunteers who assisted with interviewing applicants for these positions: Kathy Clemens, Henny Delange, Jerry Reitsma, Brian Gauthier, Ron Fitton.

Coverage challenges:

- No full-time staff following David Lewis departure mid-September
- One occasional property staff on 1-month vacation in October
- Two new hires for property staff trained and scheduled in, one resigned after two weeks
- One property staff requested reduced hours, another has health-based restrictions
- From mid-September to present, General Manager and one volunteer have provided limited property and rental management, with many issues set aside until full staffing is reached. This will impact building care and rental revenue until resolved.
- 4. The number one priority for OAG in 2023 will be facilitating the successful team-building among the operations staff group, all but one of whom have been with us for less than four months! Providing all the supports available will be job 1 for the OAG in 2023.

Communications Advisory Committee

Concerts, worship services, discussion groups, fundraising events, social justice work, environmental initiatives, volunteer opportunities.... Many things are happening at Beach United. Our communications challenge is making sure people know about them.

Until last fall, promoting Beach United's activities was coordinated by volunteers, with significant assistance from Cate Duff. Cate provided graphic design and promotional support in addition to her other duties as Office Administrator.

Recognizing that a well-supported communications strategy is an investment in Beach United's success, our Board posted the part-time position of Communications Coordinator. In October, we were delighted to welcome Allison Woo to this role on Beach United's staff. Allison's work is supported by a Communications Advisory Committee. Its members are Jo-Anne LaForty, Mary Anne Lemm, Leigh Bowser and Rev. Greg Daly.

Allison is bringing fresh eyes, creative design, smart innovations and a collaborative approach to Beach United's marketing activities. We're already seeing the impact of her skills and experience on our website, social media, posters and local advertising, and we're looking forward to more development in these areas.

General Manager's Report

By the time you read this I will no longer be able to claim 'newbie' status but at the time of this writing, experiencing a newbies reaction to the Minister's considerate request to share some thoughts in the annual report: Yikes! In typical Greg fashion, he listened, gave helpful feedback; and support for suggestion I keep it short and sweet. Herewith, dear Friends. In my time as General Manager, I have been warmly welcomed by every single person who has crossed my path - from volunteers to staff to executive to guests, the BUC community stepped up with a smile to share their deep knowledge, provide context, put up with my endless questions and offer all manner of support. I'm very grateful to be among such a sharing, caring and frankly brilliant bunch in a truly inspiring setting. Thank you. I look forward to learning more, expanding the BUC presence in the community and bringing new and returning communities into the BUC. I'm hopeful for the future, eager to engage and again, grateful to be on Team BUC.

Music Director's Report

2022 was a year of growth and rebuilding for the music program at Beach United, after the pandemic severely restricted most music making activities in the church building. Here are some of the highlights from the past year:

- The choir returned to in-person rehearsals in late 2021, and rejoined Sunday worship services in March, 2022. The choir also performed its first Christmas Cantata since 2019 this year (to much success), entitled 'The Seven Noels'.
- The return of in-person congregational singing began in August, 2022 to considerable excitement after 2 and half years of its absence.
- We were lucky to have Mike Daley continue his fabulous music lecture series in 2022, with well-attended lectures on both the history of jazz music and the Beatles.
- The **Music for the Soul** series continued this year, returning to in-person concerts. The series, which features up-and-coming singer/songwriters was pleased to welcome such fabulous artists as Rebekah Hawker, Kathryn Merriam, and Sarah Beatty.
- Under the direction of Jo-Anne LaForty, the long running **Jazz and Reflection** had another fabulous year, as it returned to fully in-person concerts in 2022. Highlights of the season included performances by Alison Young & Jeff McLeod, Jane Bunnett and Danae Olano.
- 2022 saw some major repairs being undertaken on the church organ, and the continued success of our Organ concert series. In 2022 we were lucky to have a diverse set of performers, with returning favourites like Christopher Dawes, and newcomers Rashaan Allwood wowing audiences.

Pastoral Care Report

Our pastoral care team (Greg Daly, Susan Dowling, Marian Hilton, Pat Plue, Shirley Underwood and Marney Winn) is committed to providing support and encouragement to members of our church family, with special emphasis on those who, for a variety of reasons, are unable to participate in regular church services. The church bulletin and weekly sermon are sent to several of these members.

Covid restrictions and concerns have proven to be challenging but, over the past year, we have managed over 35 visits, 250 phone calls and sent 80 cards as well as organizing delivery of flowers at Easter and Christmas. As a consistent pillar of our team, Greg has offered pastoral care support in a variety of ways including in-person and telephone conversations. They take place in church, in homes and in various creative locations such as Glen Manor Rayine and Juice and Java.

In 2022, several long-standing members of our community died, and we were grateful for the opportunity to celebrate the lives of Joan Square, Margaret Philpot and Inge Siber through services and gatherings. Baptisms and weddings offer us additional celebrating moments and Greg has committed himself to being available to support these important events in our community. We are thankful for all the members of our congregation who quietly offer random acts of kindness, supporting one another.

Beach Interfaith Lunch Program



This past year can truly say there was never a dull moment. Our operations were severely impacted by COVID once again this year. We managed to serve inside only, outside only and combination of inside and outside. We only had 2 weeks where we were not operating. Volunteers needed to have up to date vaccination status and be masked while volunteering. Happy to say we had no known cases of transmitting the virus in our community. We have had quite a lot of volunteer turnover and are happy to be holding steady at 22 volunteers. We frequently have a volunteer waiting list.

We managed to provide just over 900 meals for our guests. These circumstances have revealed a whole new set of people needing support. Many guests drop by now to pick up takeout orders for family members who cannot get out.

Let us close by thanking the many folks that regularly provide donations of food and fund. We are blessed!

FOOD, POLITICS AND CLIMATE CHANGE

Caring for one another was central to Jesus' teachings: Feed the hungry, satisfy the thirsty, shelter the homeless, clothe the naked, care for the sick, visit those in prison. Moreover, he announced that God's kin-dom of peace and justice is at hand and challenged structures of discrimination and oppression. (A Song of Faith)

At Beach United we work with other churches, faith traditions, and people of goodwill to eliminate poverty and injustice, identify its root causes, and protect those who are most vulnerable.

We continue, as we have for many years, to feed people in our community. In conjunction with neighbouring churches in the Beaches Interfaith Lunch program, we serve a hearty lunch each Thursday to people in our community who are in need of food and social connections. After several years of leadership by Jim McKibbin, the program is now directed by Jim Winn, whose creative meal ideas are well received by our guests.



After more than a year, the community food pantry was closed at the end of the year. The original idea was that some of our neighbours would put food in the pantry to be taken by other neighbours who needed it. The program was moderately successful, with food contributed by members of Beach United and the occasional neighbour. After a time, we decided to refocus our energies on the lunch program, where we are able to provide social support along with the food.

In addition to these organized support programs, Beach United staff provide informal support to many people that come to our doors, including sharing a coffee, a listening ear and direction to a place where further support can be found.

Through our direct support to people in need we become acutely aware of the social policies and structures that underlie human suffering. Working with other local faith communities, we have raised up our concerns through all-candidates meetings for elections at all levels of government.

A small but loyal group continued to meet in early 2022 to explore ways to respond to the climate crisis and other environmental concerns. We wrote letters on current issues and shared environmental tips. And we offered our support to the successful effort lead by Ron Fitton to install chargers for electrical vehicles in our adjacent parking lot as a graphic demonstration of our church's commitment to environmental stewardship. The Environmental Action Group took a break mid year to explore other issues; but is exploring new ideas for the new year, including hosting an Environmental Fair in the spring. 


Online Speakers & Events


In 2022 in an attempt to stay engaged and connected with each other **Beach United Church** had a rich variety of **online speakers and events**:

Knitting Group

Just before Christmas our Knitting for Shivering Children group received a courier package from Saltspring Island, British Columbia. It contained four thick knitted sweater vests made by a friend of a member of Beach United. The vests are part of the 11 huge bags of blankets, sweaters, hats and toys we have made so far since September 2022. We will deliver them, and what we make this winter and spring, to Canadian Food for Children (CFFC), a charity that ships a container a day of food, clothing and medicine to 16 countries around the world.



These handcrafts are made by our local core group of about 40 knitters and crocheters, and from uncountable places across Canada, such as Saltspring Island, who hear about our work.



We resumed in-person meetings in March after a two-year pandemic hiatus and once again decorated the church in May with an incredible selection of colours and patterns (668 items in total) that Rev. Greg Daly blessed on Mother's Day. In June, CFFC shipped those blankets, sweaters, hats and toys to Angola, El Salvador and Dominica. In addition, we raised \$460 for BUC's food programs by selling our handmade cats, whales, bears and octopi at the Christmas Marketplace in December. Our goal for 2023 is to once again reach our pre-pandemic total of 1,500 items a year. And to keep laughing while we share knitting stories. Every stitch counts!

To be followed shortly by late summer's colourful flowers, sumac, hosta, bee balm, japanese anenome, browneyed susans – lorded over by the three gloriously blooming Roses of Sharon!

AND LOOKING FORWARD TO 2023... It will be challenging: the departure of Matt and Sally will leave a huge hole, and new avenues may be required to provide the expertise and time required to maintain the garden in its present form, perhaps including reconfiguring for a new future.





Solar Energy for Beach Co-op Inc Report (SEBCI)

The Solar Energy for Beach Cooperative, Inc. (SEBCI) works with Beach United Church to provide green energy for the Toronto Hydro grid. SEBCI, a public non-profit cooperative governed by a board of 6 directors, is responsible for oversight of the solar installation on the roof of BUC, and its operation, maintenance, and financial management.



In 2022, the SEBCI solar installation generated 57,649 kilowatt hours of green energy, down slightly (2.5%) from last year due to weather conditions. As a result of this and decisions to increase roof rental payments to Beach United Church, our net income was lower than 2021. This was partially offset by elimination of audit fees as, by law, an audit is no longer required. Our financial results are below.

Since its start in 2014, the Co-op has generated 504.58 MWh of clean renewable energy. According to the U.S. Environmental Protection Agency, this has the following Carbon Dioxide Equivalents:

- the carbon sequestered by 441 acres of forest in one year, or
- greenhouse gas emissions from 80 passenger vehicles driven in one year.

SEBCI membership is open to any member of the public with the payment of a small membership fee. Meetings are held once a year. We welcome new members. If you are interested in joining, please contact Jerry Reitsma (jreitsmn609@rogers.com).

Treasurer's Report

After several years of dedicated service as Treasurer, David Kiel stepped down in the spring of 2022. We are all grateful to David for all of his work, especially working with the Board to keep the church finances afloat through the difficult years of the pandemic.

I am happy to step in to be the new Treasurer and to try to fill David's big shoes. In preparation for the Annual Congregational Meeting on April 2, at which the 2023 budget will be approved, I am honoured to work with a Financial Planning Working Group to bring their expertise to the task. The Working Group Members are David Kiel (past Treasurer), Martin McFarland (Trustee), Greg Daly (Minister), Karen Cornece (General Manager) and Paul Dowling (Treasurer).

While not participating in the Working Group, Ron Fitton has committed to focus his energies on working with Karen and the OAG to develop reliable budget estimates for operating revenues and expenses.

The 2022 Year End Financial Statements are pasted on the following page. The bottom line, with expenses deducted from revenue, is very close to the \$72,000 deficit projected in the budget approved last year.

Revenue from Parking and Rent is dramatically higher than budgeted. These additional revenues enabled the Board to agree to a proposal to install 6 Electric Vehicle chargers in the parking lot adjacent to the church. With rebates available to support the installation, the net cost of the chargers is about \$9,000 each. While the financial return on this investment will not be immediate, there will also be benefits to the environment and to Beach United's stature as a champion of environmental sustainability. Our past commitments to solar collectors and the water permeable parking lot continue to contribute to a healthier environment.

As we enter a new budget cycle, we continue to be challenged to invest wisely in our church for longer term sustainability. Your responsibility, at the Congregational meeting will be to consider how to balance short-term and longer-term considerations and to determine how expenditures in the short term will have benefits, both financial and mission focused, in years to come.

The Financial Working Group and the Board will have the responsibility to identify areas where investment in the future will have dividends and to propose the actions that we will take to achieve the proposed budget.

I look forward to working with the members of Beach United to share this responsibility.
